# II. APPROVAL OF MINUTES:

#### IV. DIRECTORS REPORT:

Jimmy Callaghan will be developing a logo for Parks and Rec. The logo will be used on correspondence, forms, and signage at our parks. He is also supporting the possibility of a garden at the RRAC in the open area near the well to be sponsored by a local gardening group.
