Superintendent Stevens provided an overview of the budget document. He reviewed the Board goals, instructional summaries, enrollment, staffing, grants, overall budget process and assumptions.

5. Program 1 Center Elementary School, Review and BOE Discussion

Superintendent Stevens shared the details of program 1, the grant offsets and significant changes to the program. Director Conley and Principal Cushing shared the importance of the math coaching position. Board members asked about course offerings, Donors Choose, the math coach, and funds for supporting childcare on the early dismissal days.

6. Program 2 Hall Memorial School, Review and BOE Discussion

Superintendent Stevens shared the details of program 2, the grant offsets and significant changes to the program. Principal Tshonas shared the importance of the math coach. Board members asked questions about clubs, sports, the per pupil expenditure, and a math interventionist.

7. Program 3 Special Education & Related Services, Review and BOE Discussion

Superintendent Stevens shared the details of program 3, the grant offsets and significant changes to the program. He shared that the Board has a legal obligation to meet the needs identified in a student's individualized education plan, which includes the addition of a teacher

and outplacement. Superintendent Stevens highlighted Director McGinley's outstanding management of funding paraprofessionals. Board members asked questions about grant funding, WEALTH, the number of students identified with special education services, the board certified behavioral analyst, training for the new IEP software, and early intervention practices.
