The funds will be utilized to hire consultants to assist the SBC with the review of options including but not limited to renovation, addition or a new school, and any other items to assist the SBC in fulfilling their charge.

To see if the townspeople, on the recommendation of the Board of Selectmen, will adopt the updated transfer station fees, effective August 9th, 2022, for the Town of Willington Transfer Station, 49 Hancock Road in Willington, CT.
