First Selectman Wiecenski called the meeting to order with the following in attendance: Selectmen Makuch & Blessington and residents. First Selectman Wiecenski led the Pledge of Allegiance.

Approval of Minutes:

<u>First Selectman Status Report</u>

First Selectman Wiecenski stated that not much has changed as we continue our spending freeze. We are still holding off on filling the Land Use assistant position, as requested by the Board of Finance, who has asked for a little more time before moving forward.

The Assessor position vacancy closes on Friday, January 5th and the Accounting Associate position closes on Monday, January 8th.

Public Works:

Derek reported that the crew has been busy with the following:

- Roadside mowing
- Install calcium tanks on plow trucks
- Vehicle/equipment repair
- OSHA hearing conservation training
- Roadside brush removal
- Push up salt deliveries
- Plow & sand roads
- Street sign inventory

- Clear sidewalks
- Make sand/salt mixture

Derek reminded residents that the sand/salt mixture is available at the Transfer Station during operating hours, please plan accordingly. There is a 10 gallon limit on the sand/salt mixture per week. The sand and salt at the Public Works facility is not for the residents use, the facility is monitored with security cameras. Anyone seen taking material will be charged for material that was taken and could face other penalties. Thank you for your cooperation.

Selectman Makuch moved to re-appoint Marilyn Schreiber as a regular member of the Willington Conservation Commission; effective December 2, 2017; expiring December 1, 2020 Selectman Blessington seconded the motion.

Selectman Blessington moved to re-appoint Kathy Demers as a regular member of the Willington Conservation Commission; effective December 2, 2017; expiring December 1, 2020 First Selectman Wiecenski seconded the motion.

Robin Campbell noted that she needed to apologize to Conservation Commission Chairman, Peter Andersen, who had sent an email back in November confirming the re-appointments of the Conservation Commission members. The email unfortunately got buried and lost; otherwise the members would have been appointed in December before the appointments had expired.

First Selectman Wiecenski moved to re-appoint William Bland as a regular member of the Willington Zoning Board of Appeals; effective January 1, 2017, expiring December 31, 2019 (2 year term) Selectman Makuch seconded the motion.

First Selectman Wiecenski thanked the appointees for their willingness to volunteer on these boards.

Old Business

A. Crumbling Foundation Update

First Selectman Wiecenski stated that she has no updates at this time.

B. Budget Update

The Selectmen had their first budget meeting earlier and reviewed the Assessor and Town Clerk's line items. As of right now, the budget is at or under budget and looks good. The next meeting will be held on January 9th at 6PM in the upper level (Selectmen's Conference Room) at the Town Office Building.

The CIP Committee will meet tomorrow night at 6:30 PM in the lower level.

C. Video taping of meetings

As a result of the last discussion, Selectman Makuch had looked into some policies that other towns have in place. First Selectman Wiecenski stated that she looked at the YouTube site and does not think we are reaching the audience that we would really like to see. She noted that she doesn't think it is from lack of interest, but rather that people do not know where to look. If we are going to continue to do so, we need to let the people know how to find the content. She then asked Selectman Blessington if he had any further information to share. Selectman Blessington stated that he does not really have anything, but started a discussion with Mr. Bulick (Chairman of the Board of Finance) who is interested for the board of Finance. He then stated if we (Selectmen) can get it up and running, then the other boards will follow suit.

Selectman Makuch stated that she will email a copy of the draft policy to Robin Campbell, who will then forward to the board for review and further discussion at the next meeting.

Lastly, First Selectman Wiecenski thanked the Public Works crew who has been inundated with storms and frigid temperatures of late. The crews have been working hard to keep our roadways cleared. She added that they had to work on Christmas day and although it comes with the territory, she stated that it is important to let them know that their hard work does not go unnoticed.
