First Selectman's Status Report

First Selectwoman Wiecenski provided an update on the Parks & Recreations Director's position. The hiring committee conducted 1st and 2nd interviews and have offered the Parks & Recreation Directors position to Bethany Cologna she will be starting on February 3rd 2021.

The Emergency Task Force Committee has not reconvened since the holiday therefore there is no update to provide.

Mold in the basement at the TOB, we are still awaiting the official notice but we have been told that the initial indications are that the claim for document preservation will be denied. They have passed our claim from CIRMA on to CHUBB which is CIRMA's pollution carrier. We are waiting to see if the remediation is covered under the pollution binder.

Pistol Permits, there has been a large uptick in pistol permit application. Many surrounding towns have communicated the increase. For FY 18/19 there were 21 pistol permits issued. From March 2020 to now we have 62 pistol permit applications with 5 additional appointments this week. Many of them reject fingerprints as unreadable to no fault of ours. This rework is extensive at times, there is several applications that have rejected up to 8 times. Although this analysis extends through 2 fiscal years we wanted to get a sense of applications processed from the onset of COVID to present which has tripled from past fiscal years.

Old Business

A. Cadlerock Remediation Application

First Selectwoman Wiecenski moved to approve the submission of a 2021 Brownfield grant in the amount of \$250,000 to remediate existing contamination on the Cadlerock property located in the towns of Ashford and Willington.

B. COVID-19 Update

First Selectwoman Wiecenski provided an update Willington has had cumulative 162 COVID cases, with 1 additional death, 8 probable cases which is an increase of 36 cases since our last meeting on January 4, 2021. We have seen a large increase in positive cases due to testing at High Chase. Vaccines are in phase 1B, anyone 75 years of age and older are now eligible to receive a vaccine. In collaboration with Jennie Arpin the Human Services Director we have been discussing how we can help our seniors who might need assistance navigating the appointment process. We will be meeting with EHHD to discuss this issue as a region. The State has received approximately 44,000 vaccines weekly and the entirety of phase 3 is 1.3 million residents. This process will take time and we ask residents to be patient. Governor Lamont announced a tiered approach to phase 1B which will begin late February which include individuals with underlying medical issues and front line workers. There are currently over 85 sites administering vaccinations. We have been fortunate in the Town of Willington to not have COVID cases effect our Town Hall. Recently Andover and Scotland Town Halls have had to close and go full remote due to COVID exposure.

First Selectwoman Wiecenski provided some updates and reminders. Our December 2020 police report indicated there were 7 accidents, 9 criminal investigations, 2 larcenies, 4 arrests and 305 non reportable matters. Motor vehicle enforcement, there were 23 total traffic stops, 1 DUI, 4 misdemeanor summons, 9 infractions & 10 verbal warnings. To wrap up 2020 we had 353 calls for service and 5,036 total calls for the year of 2020.
