I. Call to order

Meeting was called to order at 7:03 P.M.

II. General Discussion/ Present to speak

IV. Discussion of RRAC drainage

Stuart reported on ARPA funding and goals for said funds. He stated plans are being finalized by Karl Acimovic. After which the work could be put out to bid.

V. Eagle Scout Project

He mentioned a possible late September/early November deadline for completion.

VI. Directors Report

- A. Newly hired Rec Director James Callaghan stated summer camp is moving along and will run through August 11th. No issues to date. A meeting was held with staff to try and bring more positivity to the camp experience. ARPA funds are currently covering 50% of the cost for campers. Approximately 40 kids per week attend.
- B. Halls pond is open and running with 1 head and 2 other lifeguards. ~ 25 passes have been sold to date. The lifeguards and Public works are keeping the beach in top shape. Several new buoy rope lines have been installed to replace old worn ropes. Eastern Highlands Health have been testing the water and no issues have been reported.

- C. Wednesdays in the park is up and running. Trying to reschedule Bruce John for July 26th. Rock solid Alibi to be rescheduled possibly on a day other than Wednesday due to conflicts. Director Callaghan will put an event page on Facebook to promote more interest. No food trucks scheduled for this year's series. Eastern Highlands has expressed interest in having a table at the concerts to promote Narcan awareness.
- D. Director Callaghan brought up several observations:
 - 1. Possible need for trash receptacles on far side of walking path
 - 2. Leg raise elbow pads are worn and need replacement.
 - 3. Possible roof over exercise equipment to stop sun and water damage.
 - 4. High fencing needs attention in the right rear corner.

Erika mentioned, and it was agreed, the wood chips in the play area need to be replenished.
