

Another school year has started and fall is upon us! There are so many things going on around town and we hope you take some time to take advantage of the opportunities Willington can offer. There is also a lot happening at the Town Office Building and with Public Works as we prepare for the winter (and budget season) ahead. The roadside mowing continues as the rain storms we had this summer put things behind. The Town Office Building will be getting some much needed repairs. The front steps and ramp are being replaced beginning October 22<sup>nd</sup>. A temporary ramp will be installed on the side entrance, which will serve as the main entrance until the repairs are complete. ## Animal Control



Reminder that ALL dogs over 6 months of age, living in CT MUST be licensed with the Town Clerk in the town which they reside. Dog licensing is done every June. Any dog owner found to be owning/keeping a dog on their property which is not licensed will be subject to a \$75.00 infraction.

Dog licenses are \$8.00 for spayed/neutered dogs and \$19.00 for intact dogs. There is a \$1.00 per month penalty fee charged by the Town Clerk for each month you are overdue. You will need to bring a copy of your dogs current rabies certificate.

After receiving the dog license delinquent list from the Town Clerk, it appears that we still have quite a few dog owners who overlooked their renewals this year. Also, if you licensed a dog last year which you no longer own, or if you have moved out of town, please contact me so we can remove the dog from our list.

If your dog is not wearing a blue triangle shaped tag with 2018 on it, please check to be sure he/she is licensed for this year.

The Town Clerk's Office is open Monday 12:30 to 7:30 or Tuesday—Friday 9:00 to 2:00. If you have any questions, please don't hesitate to email me at [animalcontrol@willingtonct.org](mailto:animalcontrol@willingtonct.org).

Thank you to those who have already licensed and for the cooperation of all others in getting their dogs renewed and or new dogs licensed! ## Assessor



The Assessor's Department would like to thank all property owners for their continued cooperation during the 2018 town wide revaluation process. Once the Assessor's Office has completed the 2018 revaluation of all real property, notices of new assessments will be mailed to property owners.

Since the last revaluation conducted in 2013, real estate values have changed.

The following 4 questions can help you to decide if your assessment is correct:

- Is the assessment 70% of current market value?
- Does the Assessing Department have the correct information on my property?
- How much are similar properties in my neighborhood selling for?
- How much are similar properties in my neighborhood being assessed for?

If you have a question or concern about the proposed valuation, you will be given the opportunity to request an informal hearing. This appointment is meant to allow a brief discussion about the valuation process. Most hearings will last 10-15 minutes.

It is important to remember that an informal hearing is not a forum to discuss taxes or town politics nor is it an in-depth class on appraisal practices and theory. It is strictly meant to answer general questions on the proposed property assessments. The hearing officer will take notes during your meeting to document the information you have discussed. They will later determine if further review of your property assessment is necessary based on these notes. The proposed values are not final until all hearings and any data or value changes resulting from the hearings are completed.

At the conclusion of the hearings for your town, appraisal staff will review the notes from your hearing and any information you have provided on your property. They will make changes to the data and/or value of the property if appropriate. After this final review process is complete for all properties, another notice is sent to you. The new value on this notice will reflect the changes made based on your hearing. This value will now be considered your new assessment and will be reflected in the Assessors records.

If any property owner believes the assessment on their property is in excess of its fair market value, they should appeal it before the Willington Board of Assessment Appeals. If the property owner still feels that after their meeting with the Appeals Board the assessment is still incorrect, they may appeal to the Superior Court. Please contact our office at (860) 487-3122 with any questions. The Assessor's Office is open Monday 12:30-7:30 and Tuesday through Friday from 9:00am to 2:00pm.

## Building Department

### New Building Code

I wanted to take a moment and share with you that a new building code edition will take effect on October 1, 2018. It comes to us after a long vetting process. There are some significant changes with the residential building code in particular. What this means is that any permit applied for beginning October 1, 2018 is subject to the provisions of the new code. The new building code consists of the following books;

1. 2015 International Building Code
2. 2015 International Residential Code
3. 2009 ICC ANSI A117.1
4. 2015 International Plumbing Code
5. 2015 International Mechanical Code
6. 2015 International Energy Conservation Code
7. National Electrical Code NFPA 70- 2017
8. 2015 International Existing Building Code

If you are interested in learning more about the code adoption process you may do so on the website of the Connecticut Office of the State Building Inspector. Should you wish to view the new code you may use the free E- Code Viewer on the same website. You will find the E- Code viewer provided by ICC under the Laws and Regulations at the bottom of the page. The international Code Council is currently working on printing Connecticut specific books for the residential and commercial building codes. When they are complete you should also be able to view them for free in the same place.

### **\*\*Safety Note\*\***

As we approach heating season it is important to have your fuel fired appliances cleaned and serviced. This includes boilers and furnaces, wood, pellet and gas heaters and stoves. Don't forget to clean and inspect chimneys and flues. You will find that properly serviced appliances will provide better reliability and will function safely and more efficiently.

**Voters To Decide November 6<sup>th</sup>**  
**Ballot Question: Should There Be A Constitutional Amendment To Strengthen Protection Of Public Lands in Connecticut?**

During this November's election, CT voters will have an opportunity to decide whether there should be a state constitutional amendment that would further protect public (state) lands. Voting "Yes" on November 6th, would essentially amend the state constitution to require that before the CT General Assembly could sell, transfer or dispose of public lands it must:

- 1) First hold a public hearing; and
- 2) Achieve a two-thirds supermajority vote on lands held by the Connecticut Department of Energy & Environmental Protection (e.g., state parks, forests, wildlife management areas, etc.) or the Department of Agriculture (e.g., state-owned farmland).

## Conservation Commission Continued...


In Willington, CT DEEP holds and manages 1,161 acres that are considered public open space (mainly portions of the Nipmuck State Forest and Nye-Holman State Forest). The Town could potentially lose a significant amount of open space if these state forest lands are sold or given away in the future.

Currently, the General Assembly can sell, swap or give away state parks, forests and other valuable public lands to private companies or local governments with little to no public input. By requiring public hearings, the proposed amendment would ensure an opportunity for public comment and government transparency related to decisions about state parks, forests and other public lands.

Public lands are valuable to Connecticut residents and wildlife. For many people, our state forests and parks are their only source to enjoy the outdoors and learn about nature. State forests and wildlife management areas provide important habitats for many animals and birds. These public natural areas and forests are also critical for protecting our water resources by filtering out pollution.

The Willington Conservation Commission supports the proposed Constitutional amendment, since it would ensure public participation in the decision making process.

During the summer, the Society was able to purchase a second metal fireback for our taproom fireplace. The previous fireback was moved to the kitchen hearth. Now the brick work in both fireplaces will be protected from the erosion caused by the heat of the fires.

As an off-shoot of the Willington Garden Club, there was an interest to research and plan a period kitchen garden on the East side of the Tavern building. Anyone interested in joining this effort may contact Pam Wheeler at 860-429-9804 for more information.

## IMPORTANT NOTICE REGARDING PERMIT FEES

Effective November 1, 2018 new fees will be assessed for all building, electrical, mechanical and gas permits as approved by the Board of Selectmen at their October 15, 2018 meeting.

The following is the **NEW** fee schedule:

- All permits shall have a minimum fee of \$35.00 for the first thousand or portion thereof.
- For 1 and 2 family residential homes, an additional fee of \$12.00 per thousand or portion thereof after the first thousand, shall be assessed.
- For other than 1 and 2 family residential homes, an additional fee of \$14.00 per thousand or portion thereof after the first thousand, shall be assessed.

In addition, the state educational fee of \$.26 per thousand or portion thereof, shall be calculated and added to the regular municipal fee.



### Did you know?



"Conor's Law," which expands the helmet requirement in Connecticut, takes effect October 1, 2018.

Below is a summary of Public Act No. 18-167 outlining the expansion of protective headgear requirements. The new law expands the types of activities during which children under age 16 must wear protective headgear and **adds parks** to the places where such headgear must be worn. Current law requires any child under age 16 who rides a bicycle on a public road to wear protective headgear that meets the minimum specifications established by the American National Standards Institute or the Snell Memorial Foundation. The new statute expands the types of activities during which these children must wear such protective headgear **to include skateboarding, non-motorized scooting, roller skating, and in-line skating; it adds parks, including skateboarding parks, to the places where the protective headgear must be worn;** and it requires that the protective headgear is properly fitted and fastened. By law, failure to wear protective headgear is not considered a violation or an offense and cannot be considered contributory negligence by a parent or a child or be admissible in any civil action.

**Non-Resident Policy:** Non-residents will be charged an additional \$5.00/\$10.00 depending on the program/bus trip.

All refunds must be in writing, received at least a week prior to the start of the program (three weeks if a bus trip) and will be assessed a \$5.00 processing fee.



# Town Parks & Amenities



## Fenton-Ruby Park and Wildlife Preserve:

Moose Meadow Road and Burma Road; hiking/walking trails, bird watching, fishing, non-motorized boating, cross country skiing, snow

shoeing and picnic area.

## Knowlton Property:

Mason Road – Hiking Trails

Wilmington's Public Works Department recently finished constructing a parking lot for hiking trail access on Mason Road. This lot will allow safe parking for access to the Talmadge Spur Trail and the Knowlton Spur Trail. Both trails connect to the Nipmuck Trail, part of the Connecticut Blue Trail System.

## Talmadge Tract:

Mason Road – Hiking Trails (adjacent to the Knowlton Property)

## Chenes Roches Preserve:

Chenes Roches (transl. oaks rocks) is a 56-acre wooded preserve in northeast Wilmington and owned by Joshua's Tract Conservation and Historic Trust. Trails wind through a varied terrain of hardwood forests, stands of pines and along a hemlock-shaded stream in a steep-sided valley. A round trip of 1.8 miles will take you across several small spring-fed streams and an altitude change of about 250 feet from the parking lot to the valley stream. A trail map and additional information about the preserve, including directions, can be found on the Joshua's Trust website, [joshustrust.org](http://joshustrust.org). There is a kiosk with trail maps at the small parking area 500 feet past the south end of Laurel Drive. **Please stay on the trail and respect boundaries where the trail passes near private property.**

Note: The parking area is not plowed in the winter and parking on the road is not advisable.)

## River Road Athletic Complex - 511 River Road:

Baseball field, basketball court, pavilion, playscape, swings, multi-sport field, volleyball sand court, walking path (one lap = .33 miles) and outdoor fitness equipment. No golfing allowed. Dogs are welcome but must be leashed and cleaned up after. Doggie poo bags are available. Complex is CARRY IN-CARRY OUT. Dogs are not allowed on the baseball field. **\*\*State Statute 22-364 states that dogs must be under the direct control of their owners at all times when using town parks. It is the dog owner's responsibility to clean up all dog waste.**

Baseball and Softball fields

Overlooking the Roaring Brook, a popular fishing spot during fishing season.
